



NON-LICENSED MOTORIZED VEHICLE PERMIT
(ATVs, GOLF CARTS, MULES & ALL 4 WHEELERS MUST BE PERMITTED)
ALL RULES AND REGULATIONS MUST BE OBEYED IN ORDER TO KEEP YOUR PERMIT!

NON-LICENSED MOTORIZED VEHICLE RULES:

PLEASE READ the FOLLOWING CAREFULLY:

General Rules:

- ALL MINORS MUST HAVE A PARENT OR LEGAL GUARDIAN TO SIGN FOR THEM.
- Band must be displayed on left handlebar or around left windshield of golf cart.

AGE LIMIT:

- **People ages 12 and under cannot ride/drive alone.**
They must be accompanied by someone over the age of 18. If someone under the age limit is caught driving w/o an adult, their ATV band will be revoked and taken.
NO REFUNDS

OPERATIONAL RULES:

- **Speed limit is 5MPH ANYWHERE in the park.**
- **You cannot cut through other camper's sites/cabins or bother them.**
- No donuts, wheelies or other wild riding allowed anywhere in park
- **Keep alcoholic beverages in your campsite ONLY! No drinking alcoholic beverages while riding.**
- NO RIDING PAST PROPERTY FENCE LINE ONTO NEIGHBORS PROPERTY (EVEN WHERE FENCE HAS BEEN KNOCKED DOWN) NEIGHBOR HAS INSTRUCTED LAW ENFORCEMENT TO ARREST ANYONE CAUGHT ON HIS LAND. ADULTS MUST SIGN ATV/GOLF CART RULES.

PERMIT AND RULES WAIVER BEFORE BANDS ARE ISSUED:

- The number of riders is not to exceed the seating limit of the vehicle.
- **Pedestrians (people on foot) have the right of way.** Do not drive close to them.
- Ride at your own risk.

ATV SPECIFIC RULES: (ATVs include: four wheelers, mules, modified golf carts, dirt bikes, etc.)

- All wheels **MUST** be **PARKED at DARK**
- **ATVs CANNOT be driven through the park unless they are going to or returning from the trails.** There is NO reason for an ATV to be at the front of our park or PARKED anywhere other than the owner's campsite. You may only ride your non-licensed 4-wheeler from your site / cabin directly to the ATV trail.
- The ATV gate is located on the back side of the fishing lake. You must ride 5 MPH thru the park behind cabin 4 to the trails. **Opened 8 am to Sundown.**
- All minors must wear proper protective gear and have a parent or legal guardian to accompany them while riding. Obey basic traffic signs. Most of our streets are one way. **Must drive 5 MPH, Ragans Family Campground** is not responsible for any injury or property damage incurred while you are operating a non-licensed motorized vehicle; if ANY of the rules are not complied with, your permit will be revoked without refund and you will not be allowed to ride for the remainder of your visit / or will be asked to leave the park without a refund. We have no control over Mother Nature or break downs so there will be no refunds due to these reasons.

Acknowledgment and Assumption of Risk

_____ **Initial**

1. I am aware of the dangers and the risks to my person and property involved in participating in: any and all activities at **Ragans Family Campground**. I understand that these activities involve certain risks for physical injury. I also understand that there are potential risks of which I may not presently be aware. Because of the dangers of participating in these activities, I recognize the importance and agree to fully comply with the applicable laws, policies, rules and regulations, and any supervisor’s instructions regarding participation in these activities.
2. I understand that **Ragans Family Campground** does not insure participants in the above-described activities, that any coverage would be through personal insurance, and **Ragans Family Campground** has no responsibility or liability for injury resulting from these activities.
3. I voluntarily elect to participate in these activities with knowledge of the danger involved, and I hereby agree to accept and assume any and all risks of property damage, personal injury, or death.

Waiver of Liability and Indemnification:

_____ **Initial**

1. In consideration for being allowed to voluntarily participate in the above-referenced event, on behalf of myself, my personal representatives, heirs, next of kin, successors and assigns, I forever:
 - a. waive, release, and discharge **Ragans Family Campground** and its agencies, officers, and employees from any and all negligence and liability for my death, disability, personal injury, property damages, property theft or claims of any nature which may hereafter accrue to me, and my estate as a direct or indirect result of my participation in the above referenced activity or event; and
 - b. defend, indemnify, and hold harmless the **Ragans Family Campground**, its agencies, officers and employees, from and against any and all claims of any nature including all costs, expenses and attorneys’ fees, which in any manner result from participant’s actions during this activity or event.
2. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident or illness during these activities or event. This release, indemnification, and waiver shall be construed broadly to provide a release, indemnification, and waiver to the maximum extent permissible under applicable law.
3. I the undersigned participant, affirm that I am at least 18 years of age and am freely signing this agreement. I have read this form and fully understand that by signing this form I am giving up legal rights and/or remedies which may otherwise be available to me regarding any losses I may sustain as a result of my participation. I agree that if any portion is held invalid, the remainder will continue in full legal force and effect.
